### 7. Consideration and adoption of the 2021 Annual Report and audited Balance Sheet

- Tracy McClenaghan presented the Annual Financial Report and gave a summary
- Tracy reiterated that 2022 is the year to invest in the courts. We have money set aside for this and with a federal election due, it is a good time to approach our members of parliament.
- West Pennant Hills Netball Club noted that there was an error with the Auditors report. It referred to a page number that wasn't there.
- After some discussion it was decided that Sue Watts, Administrative Assistant, would contact the
  auditors as soon as possible. This was done and they advised that it was an error on their part with
  page numbering. Clubs were subsequently notified.

### 8. Appointment of Auditors for 2022

- It was decided at the 2020 AGM, to go to the marketplace to look for new Auditors. Due to interruptions with Covid, during the 2020 and 2021 seasons, this was put on hold.
- Jennie proposed that for 2022 we look for new Auditors again and any suggestions will be brought to Council in due course.

Moved Tracy McClenaghan, seconded Thornleigh Netball Club – all in favour.

#### 9. Proposed Fees

- The 2022 Fee structure was presented for approval.
- Jennie thanked Cate Newman and Tracy for all the work they have done putting together fees for 2022.
   As per previous reports we will be moving to PlayHQ. There will be a \$10 rebate to all players and
   HDNA will absorb the transaction fee, to try to offset the shortened 2021 playing season. This will mean a \$30,000 benefit back to players.
- West Pennant Hills Netball Club asked if this deficit would impact the fees for 2023. They were advised that at this time it is unknown.

# 10. Election of Executive and Non-Executive Office Bearers for 2021

• Jennie declared all positions vacant. Due to where Lyn Burgess was sitting, Jennie declared all position filled as per nominations.

Tracy McClenaghan nominated for Carnival Convenor.

- Jennie noted that there is a big gap in the Executive without a Night Competition Convenor. This puts extra work onto other members of the Executive. She urged all clubs to go back to their members with this request.
- Jennie also mentioned that there were still a number of positions still vacant.

### 11. Election of Sub-Committees for 2021

- Jennie declared all positions filled as per nominations, with the exception of the Umpires Committee with the withdrawal of Lisette Smith and Mia Besley.
- Nominations for the Carnival Committee was opened to the floor. Lesley Milner, Cate Newman, Janette Barton, Dom Newman all nominated.

 Jennie then asked the clubs to take back the vacancies and put forward anyone they wished to nominate for the current vacancies.

#### 12. General Business

- The Draft 2022 Calendar was presented to the meeting subject to any changes in relation to Covid 19.

- Jennie mentioned the Inclusive Uniform Strategy which has recently been announced by Netball
  Australia. She advised clubs that if Clubs wished to look into this for their players they are welcome to
  do so and to please advise HDNA in due course. She also foreshadowed the Executive would present a
  by-law change at the 1st Council Meeting in 2022.
